

ORDINANCE NUMBER 329

BOROUGH OF SYKESVILLE

AN ORDINANCE SETTING FORTH RULES AND REGULATIONS IN REGARD TO THE RECREATIONAL PARK AREAS WITHIN THE BOROUGH OF SYKESVILLE, ADOPTING CERTAIN RULES AND REGULATIONS, DESIGNATING THE PARK AREAS, AND SETTING UP PENALTIES FOR VIOLATION OF THE SAME.

BE IT ORDAINED AND IT IS HEREBY ORDAINED, that the Borough of Sykesville, at the regular meeting held on the 16th day of June, 2003, does hereby **ADOPT AND ORDAIN** the following Ordinance known as the **PARK ORDINANCE**.

Section 1. This Ordinance shall be known as the **PARK ORDINANCE** and the Council of the Borough of Sykesville does hereby adopt and ordain the Rules and Regulations attached hereto and made a part hereof as the official rules for the Recreational Park area within the Borough of Sykesville.

Section 2. The "Park Areas" are defined as follows:

STAHL PARK

Bounded on the North by West Liberty Street
Bounded on the South by B & O Railroad
Bounded on the East by South Park Street
Bounded on the West by lands of Sykesville Ambulance

HIGHLAND STREET PARK

Bounded on the North by Highland Street
Bounded on the South by VanNess Street
Bounded on the East by intersection of Highland & VanNess Streets
Bounded on the West by Stahl Street

Section 3. It is the intention of the within Ordinance that the Rules and Regulations herewith adopted shall have the full force and effect of an Ordinance, and that enforcement of the same shall be in the same manner as any other Ordinance of the Borough of Sykesville.

Section 4. Any person who violates any provisions of the within Ordinance, including the Rules and Regulations, shall be guilty of a summary offense, and pay a fine of not less than \$25.00 nor more than \$250.00 for the first offense, or in lieu thereof, be imprisoned in the Jefferson County Jail for a period not to exceed five (5) days; for a


second offense, a fine of not less than \$100.00, nor more than \$500.00, or in lieu of payment thereof, to undergo imprisonment in the Jefferson County Jail for a term not to exceed ten (10) days; and for a third or any subsequent violations to pay a fine of not less than \$250.00, nor more than \$500.00, and in lieu of any such fines, to undergo imprisonment in the Jefferson County Jail for a term not to exceed thirty (30) days.


Section 5. The terms of the within Ordinance shall be severable, and in the event that any said terms should be declared null and void, or unconstitutional, only that section of the said Ordinance shall be deemed null and void, and the remaining portions of the said Ordinance shall be valid and enforceable.

Any Ordinance inconsistent with this Ordinance is hereby repealed in part or in whole, and this Ordinance shall take effect immediately the day and year first written.

BOROUGH OF SYKESVILLE
PARK RULES AND REGULATIONS

The following Rules and Regulations apply to all individuals using the Park facilities of the Borough of Sykesville:

1. Park Hours: 9:00 a.m. to Dusk, or one hour after last authorized activity. All persons are prohibited from being in the Park other than during authorized hours.
2. Children under the age of seven (7) years must be accompanied by a parent or guardian.
3. Alcoholic Beverages are prohibited from being in the Park.
4. No animals shall be permitted in the Park at any time, without the express written permission of the Borough.
5. No bicycles, skateboards or recreational vehicles permitted in the Park.
6. Assembly of more than 25 people, other than approved sporting events, is prohibited without a permit.
7. There shall be no selling of merchandise, posting of advertisements or bills without a permit.
8. Loitering, disorderly behavior, defacing or damaging property, profane or vulgar language is prohibited.
9. No Littering.
